

This Advanced Rx A/C Lift treatment should not be performed on one who has not received both the Rx A and Rx C treatments previously.

An **in-service treatment** that is applied by a licensed, skin care professional, which targets problematic areas, specifically concentrating on pigmentation, environmental damage, fine lines and wrinkles. This advanced protocol, which consists of stacking Rx A on Rx C, is suitable for a more aggressive treatment of aging skin. These slow-release, Vitamin A and Vitamin C complexes work without crossing the threshold of acute irritation.

Customizable for any client, any skin type. This treatment can be done as a facial-only service, or a comprehensive, anti-aging treatment with the *neck, décolleté, and hands* as an add-on. No contraindications.

Results vary from client to client, but one can expect little-to-no down time. Redness and sensitivity can occur and a small percentage may experience slight flaking, with potentially more flaking around the mouth, lips, and nose.

NOTES: If minor irritation or itching occur, it can be treated with OTC hydrocortisone cream.

To maximize the benefits of the VA RX Lifts, the client should purchase the take home Pro Lift kit which is done once a week for 4 weeks.

How it works: A stacked system that targets the most aggressive signs of aging. This two-step approach utilizes SERT: Selective Enzyme Release Technology[®] to deliver key actives that correct aging skin. This proprietary system delivers the highest levels of aqueous and lipid bioactives for rapid penetration across all cellular levels, with maximum results for a smoother, firmer, more youthful skin appearance.

DIRECTIONS FOR USE

PREP PROTOCOL

Step 1 Cleanse:

- Cleanse the face, neck, décolleté and hands with **VA Daily Probiotic Cleanser**.
- Perform gentle cleansing massage.
- Use steam towel or warm towel to remove thoroughly.

Step 2 Exfoliate:

- Using **VA Probiotic Enzyme Exfoliator**, apply to wet face (neck, décolleté and hands, if add-on).
- Massage gently for 3-5 minutes.
- Allow to process 5-10 minutes.
- Use steam towel or warm towel to remove.

Step 3 Apply Occlusive:

- Apply product to mask off the corners of the eyes, nose and lips.

TREATMENT PROTOCOL

Step 4 Apply VA Rx C Lift:

- Dispense vial on face (neck, décolleté and hands, if add-on).
- Massage each area with fingertips for 1 to 3 minutes until absorbed.

NOTE: Do not proceed to step 5 till step 4 has completely absorbed into the skin.

Step 5 Apply VA Rx C Booster:

- Dispense vial on top of Lift product covering the same areas.
- Massage in thoroughly with fingertips for 1 to 3 minutes for each area.

Step 6 Scalp Massage (Optional)

Step 7 Remove Treatment:

- After 5-10 minutes, gently remove Rx C Treatment with **VA Daily Probiotic Cleanser** and warm towel.

Step 8 Apply VA Rx A Lift (Stack):

- Dispense vial on face (neck, décolleté and hands, if add-on).
- Massage each area with fingertips for 1 to 3 minutes until absorbed.

NOTE: Do not proceed to step 10 till step 9 has completely absorbed into the skin.

Step 9 Apply VA Rx A Booster (Stack):

- Dispense vial on face (neck, décolleté and hands, if add-on).
- Massage in thoroughly with fingertips for 1 to 3 minutes for each area.

CLOSING

Step 10 Remove Product and Occlusive:

- Remove excess product only by patting with gauze or cotton pad.
- Gently remove occlusive product from the corners of the eyes, nose and lip area.

Step 11 Optional:

- Apply **VA Daily Essential Hydrator**, if needed.

Step 12 Apply TINTsmart SPF 35

- Apply to all treated areas before leaving spa.

Step 13 Optional VA Pro Lift:

- VA Pro A and/or C Lifts should be sold to maximize the results.

Step 14 Optional Daily Regimen:

- Recommend VA home care daily regimen.
